On the 22nd of May, I was humbled and honored to accept the Jayn Wittenmyer Distinguished Achievement Award from the Wisconsin Developmental Disabilities Board (formerly Wisconsin Council on Developmental Disabilities – WCDD).

The award recognizes someone who goes "above and beyond expectations" by providing enthusiasm, vision, broad knowledge, compassion, and leadership in the field. This results-oriented person is able to form or direct effective networks to better the lives of adults with developmental disabilities.

That "someone" is really HearthStone, and all of our valued fellow advocates and partners. From its modest beginnings as "The Parent's Study Group", we have grown as individuals and as an organization.

We have formed strong relationships with local and state legislators. We have strong relationships with service providers, our Sheboygan County Department of Health & Human Services, and with The Wisconsin Department of Workforce Development and the Division of Vocational Rehabilitation.

We have successfully advocated for millions of dollars locally and at the state and federal level to help fund programs that serve the disabled. We have launched a Respite Program in Sheboygan County in partnership with the Family Resource Center and the Department of HHS.

We have provided mortgage support so that 5 individuals and families could afford to buy a home. We have sponsored dozens of Community Education Meetings and social events for our young adults. We cosponsor an Employer's Recognition Luncheon with DVR and RCS Empowers. We provide caring counsel to families trying

to sort out the complexities of living with disabilities.

But it is truly WE. We have an exceptionally talented and committed Board of Directors with the skill and energy to act on our collective beliefs. We have an incredible Advisory Board, some of whom drive over an hour to attend our inconvenient 7 a.m. Board meetings.

WE are a truly a TEAM and I was proud to accept an Achievement Award for everything our TEAM has accomplished. And, is yet to accomplish.

Congratulations to Hearth-Stone. And my sincere thanks and admiration.

On Tuesday April 8th, Annette Hammortree, an Investment Specialist and Financial Planner traveled to Sheboygan from O'Malley and Associates in Crystal Lake Illinois, (there is also a Sheboygan office) to share her expertise professionally and personally. Annette has a son with disabilities and has used her knowledge as a financial planner and a parent to specialize in Planning for families with special needs members.

The most important items in this planning come down to a knowledgeable lawyer and planner to help. There are lots of things to keep in mind and to decide when planning for your special needs family member whenever any inheritance is involved, yours or anyone else that might remember your family member in their will. If

your family member is going to be eligible for state and federal health care, or MA, they cannot have cash assets of more



than \$2000.00. There are several exceptions to this; one being a special needs Trust. If set up properly, this is where the knowledgeable attorney comes in, the trust owns the money and a trustee has been appointed to use the assets for the benefit of the special needs family member with out jeop-

ardizing their medical benefits. There are some restrictions and rules involved with special needs trust but is an excellent tool for most families.

Annette does reach out to others in her profession to educate them with seminars on the complexity of special needs family members. Annette left us with a list of websites that she has found to be useful resources. She did especially mention the magazine, "The Exceptional Parent" as a favorite of hers. It is on the list as well. We were very lucky to have Annette come and share her "special" knowledge with us.

In summary, be sure you have an up to date will at all times and when estate planning be sure the attorney and planner are knowledgeable about Your Special situation and, ASK LOTS OF QUESTIONS.
