Vacation Time...Start Planning Now!

Are you starting to plan your family vacation?

Does the additional planning required when incorporating a disability seem overwhelming?

HearthStone recently sponsored an event that assisted in providing some valuable insight and new destination options for all. The event featured several presenters, literature, and a good discussion on what things work, what things do not, and extras that are worth planning for.

Kip Ertel from RCS Empowers started the evening by sharing some information on previous adventures, complete with successes and learning experiences. Kip also announced that they are beginning to plan for a Disney trip in November or December of 2009.

Don Douglas from Able Trek spoke and told us about the day, weekend, and 2 week trips they plan each year. To keep things interesting, Able-Trek varies their trips by alternating every 3 years with an overseas trip, a trip to Hawaii and a cruise. Remember, besides these really big trips, they have I or 2 week trips, weekend trips and day trips. Able Trek has been doing tours for over 17 years. They usually travel by coach bus and have lots of destination options every year. The closest pick up point they currently have for Sheboygan is Fond du Lac.

Two of the cabins are considered "rustic" and the other five are fully accessible, including Sheboygan's very own, which is located at Kohler-Andrae State Park. Other accessibility-friendly resorts were also suggested. It was felt they were welcoming and were happy to serve people with Disabilities. Stoney Creek Inn, in LaCrosee and Wausau and Kalahari Resorts, in the Dells were highly recommended.

The best suggestion from our discussion seemed to be, is to ask and reask when making arrangements and if it is really important, like width of doors, height of bed etc, ask them to take a tape measure and measure it for you. Saying they are accessible doesn't mean the same to everyone, (inspectors are almost always county inspectors so it can vary a lot.) Also remember, most if not all facilities have good intentions and if everyone keeps a little sense of humor almost all obstacles can be overcome.

So do some planning and get out there and see the world!

President's Report

Cautious Optimism for 2009?

Optimism because of all the time, talent and financial support HearthStone has received in 2008. Our first ever Fundraising was a great success. We heard from many of our friends with gifts small and large. It is very gratifying to see people pitch in even when the economic picture is so uncertain.

And, that's where the "Caution" comes in my "Cautious Optimism". The economy is in a turmoil, the State budget is in the neighborhood of a \$5 Billion deficit. Community Care is under financial pressures and some services are being reduced. Hopefully we can manage through these issues.

The Hearthstone Respite Care Project, a collaboration of The Family Resource Center, Sheboygan County Health and Human Services and Hearthstone of Wisconsin, completed it's fourth full year. The Project began in the 4th quarter of 2004 with 3 enrollees. The Project ended the 2008 year with 55 enrollees.

The Respite Project was recognized and honored in September with a grant for direct services from the Early Bird Rotary Foundation of Sheboygan . The generosity of this fine group will allow us to continue to offer much needed respite services to Sheboygan County families. A special thanks to Bob Feider, chairman of the Early Bird Rotary Foundation, who "shepherded" our grant request to a successful outcome.

The Project Advisory Committee welcomed a new member in 2009. Erika will bring a much needed consumer perspective to our program. We appreciate and truly need the input of all families who use the Respite program to continue to improve and grow the service. In December a survey was sent to all families enrolled in the Project. The evaluations received have been very positive. We encourage those families reading this newsletter, there is still time to send back your survey. Thank you.
