Family Care - A Year Later

Sheboygan County has had Family Care for about I-I/2 years now; Wisconsin has had IRIS (Include. Respect | Self-Direct) -- the self-directed long term program and alternative to Family Care -- available for about I year now. We thought it was time for everyone to be able to share how it is going and what has and what hasn't worked.

There were about 70 people that joined a panel at Paragon Day Services in Plymouth on September 10th for our Family Care listening session. Our panel consisted of Amy Bridges from the Sheboygan County Aging and Disability Resource Center, (ADRC) Kathy Arndt, a parent of an IRIS participant, and Betsy Abramson, program manager of the Family Care Ombudsman Program.

Amy began the evening with a presentation on what happens when someone is interested in information on IRIS. She started from the first phone call and told how the ADRC would proceed. She detailed what information they could provide to an interested consumer before they would decide if they were going to try IRIS. She also pointed out the flexibility IRIS has and how it has supports available as well.

Betsy then explained the Ombudsman Program's role in Family Care and what they have been seeing through out the state. She gave a few specific items and cases they have worked with, enumerated some general suggestions for procedures and courses of action. She then answered a lot of specific questions of how people should proceed.

Kathy followed by sharing her family's experiences with setting up an IRIS plan and how IRIS works for them. She was then able to answer some specific questions the group had about how to work with and use IRIS as well as how it adjusts to the changing needs of the consumer.

Marie Schwinn shared that she is on the Quality Assurance Advisory Committee that Community Care has set up to work on specific issues or problems and is looking for and welcomes feedback from consumers. Community Care also reminded us they employ a Member Rights Specialist for the purpose of providing help with the grievance and appeals process.

HearthStone groups rarely let us down and this meeting was no exception. There were many questions, which is why we were there and how we learn best. Betsy was even able to explain different elements of Family Care and other resources that not everyone knew about or understood. The RAD process was also talked about; this is the procedure the "team" uses to decide if they can approve a service. She also explained who was part of the team. She was able to give us a little more insight into the appeal process, especially for those that have considered it. A few other participants shared some of their experience with appeals, including an appeal that was heard in front of a Judge and an appeal that was decided with a telephone conference call.





There have been growing pains with Family Care on both the consumer and provider sides. Some items have been addressed but there are still issues that need to be dealt with. The same concerns were almost always heard more than once. Betsy also mentioned that they often see the same issues, about the same time throughout the state at their office. The most important thing Betsy shared was that consumers have to appeal decisions they do not agree with and Disability Rights of Wisconsin is there if you need help.

There was time after for more questions and sharing of contact information. We are so pleased our panel could provide so much information. Thank you everyone for attending, sharing experiences and asking questions.

I felt drawn to the beach today still reeling from the words, "I do not know Joe very well but he does not have the cognitive ability to get a degree in natural resources." The sound and motion of the waves brings comfort and salve to my wounded heart. When I feel thrown off balance this is where I come to write my thoughts and regroup. Lord, creator of heaven and earth, what is my lesson for today? My heart is open and ready to listen and learn. For several days I have been listening to the mantra, "never say never" and not sensing any movement from these words. The singer Paul Sebar at the nearby Victorian Village tiki bar echoes over the shoreline directly into my heart soothing me with lyrics I needed to hear...yes, it was part of the song he was singing..."never say never". Jumping inside and writing with renewed energy I recommitted to the original plan to support my son in pursuing his goal....after all...he already has 15 credits toward

that goal...what can those words mean..never? "He is not going to be able to make it in college....It is questionable whether it would be safe for him to get a driver's license.....it does not appear that it would be good to live in an apartment by himself...etc. etc.... My son J. R. (Joseph Robert) is now 22 years old, is living in an apartment over one hour away from home, attending college classes for three years, and just passed his road test July 29th. Though Joe has been diagnosed with PDD (Pervasive Developmental Delay) recently included in the autism spectrum, he has a determination to work in the field of natural resources and continues to jump hurdles viewed as unattainable by some. One lesson I have learned is that I do not know how he will get there but we take one step at a time and never say never.

I hope this account from a mother's perspective will bring some hope to a reader.
