Changes to Long Term Care in Walker Budget and Continued Concern about Employment "Choice".

Hello All,

While we have enjoyed a year of great progress in serving people with disabilities, there are some "storm clouds" on the horizon.

The Governor proposed wholesale changes to Wisconsin's Long Term Care delivery, without seeking stakeholder input from the legislature, the Department of Family Services, Providers and most importantly, the individuals and families served. While some of the provisions have been modified, it appears that the popular IRIS self-directed program will be "folded into" Family Care, with no clear implementation details.

Furthermore, the "promised stakeholder input" to guide DFS in the implementation of changes, there appears to be no announced opportunities before the legislature votes on the budget. A clear case of inserting policy changes into an up or down vote on the budget. Not much transparency here.

Also, you should be aware that Federal legislation has been enacted that may limit a handicapped person (and their family) choices for employment. Depending on how this is implemented, "sheltered employment" may NOT be an option and all individuals may be required to attempt competitive community employment. This threatens organizations like RCS Empowers, potentially limiting their ability to provide Community Employment Services and Pre-Vocational Services.

Stay tuned.
